

OFFICIAL CALL  
Alexandria Republican Party Canvass

As Chairman of the Alexandria Republican City Committee, pursuant to the Plan of Organization of the Republican Party of Virginia, as recommended and directed by the Committee, I, Chris Marston, do hereby issue this call for a Party Canvass to be held at Minnie Howard Campus, TC Williams High School, from 7 pm to 9 pm EDT on Thursday, March 10, 2016 for the following purposes:

a) Electing a Chairman and 123 Members of the Alexandria Republican City Committee as follows: Ladrey Senior Building, 2; City Hall, 3; Lyles Crouch School, 4; Durant Center, 3; Lee Center, 4; Cora Kelly Center, 4; Mt. Vernon Center, 4; George Washington School, 4; Fire Department Headquarters, 3; Charles Houston Center, 3; Maury School, 3; George Mason School, 3; Agudas Achim, 3; Blessed Sacrament, 3; Douglas MacArthur, 4; Chinquapin, 3; Temple Beth El, 4; NOVA Arts Center, 3; James K. Polk School, 4; Hermitage, 2; Patrick Henry Center, 2; Beatley Library, 3; Tucker School, 3; John Adams School, 3; William Ramsay Center, 3; South Port Apartments, 3; Cameron Station, 4; At-Large, 37.

b) Electing up to 595 Delegates and an equal number of Alternates to the Republican Party of Virginia 2016 Quadrennial Convention, to be held on April 29-30, 2016, at the James Madison University Convocation Center, beginning at 2:30 pm EDT for the purposes of (a) Electing 13 At-Large Delegates and 13 At-Large Alternate Delegates to the Republican National Convention to be held on July 18-21, 2016, at the Quicken Loans Arena in Cleveland, Ohio (or its alternate site); (b) Nominating two Electors At-Large to be voted for in the presidential election on November 8, 2016; (c) Electing a State Chairman; (d) Nominating a National Committeeman and National Committeewoman; and (e) and for the transaction of such other business as may properly come before the Convention.

c) Electing up to 295 Delegates and an equal number of Alternates to the Eighth Congressional District Convention of the Republican Party of Virginia on Saturday, May 7, 2016, 10 am EDT, at Kenmore Middle School, Arlington, Virginia for purposes of: (a) Electing a District Chairman; (b) Electing Three Members of the State Central Committee; (c) Electing Three Delegates and Three Alternate Delegates to the Republican National Convention; (d) Nominating one Elector to be voted for in the presidential election on November 8, 2016; (e) Nominating the Republican candidate for the office of U.S. House of Representatives; and (f) for the transaction of such other business as may properly come before the convention.

Qualifications for Participation

All legal and qualified voters of the City of Alexandria under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election at said canvass shall file a declaration on a form available from the website of the Alexandria Republican City Committee ([www.AlexGOP.org](http://www.AlexGOP.org)) by mail to Loree Gunn, ARCC, PO Box 245, Alexandria VA 22313, which must be received not later than Monday, March 7, or in person only at the February 4 or March 3 meetings of the Alexandria Republican City Committee.

Candidates for Chairman must pay a filing fee of \$200; Candidates for Member must pay a filing fee of \$100.

The Republican Party of Virginia requests a filing fee of \$35 for candidates for delegate or alternate delegate to the State Convention.

The 8<sup>th</sup> District Republican Committee requests a filing fee of \$20 for candidates for delegate or alternate delegate to the Eighth Congressional District Convention.

The Alexandria Republican City Committee requests a processing fee of \$10 for candidates for delegate or alternate delegate to either or both of the conventions.

Requested filing and processing fees help to defray the costs associated with conventions and elections with which they are associated.

If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared elected, and no canvass will be held for such purpose.

Members of the Virginia National Guard, the United States Armed Forces, Merchant Marine, or Coast Guard who are serving on active duty who comply with these filing requirements shall not be required to be elected, but shall be declared a delegate pursuant to Article VIII, Section H. Paragraph 6 of the Plan of Organization of the Republican Party of Virginia.

#### Registration Fee

There will be no registration fee to participate in this canvass.

#### Publication

By a two-thirds vote, the Alexandria Republican City Committee waived the requirement that this Call be published in a newspaper of general circulation. It shall be published on the websites of the Republican Party of Virginia ([www.rpv.org](http://www.rpv.org)) and the Alexandria Republican City Committee ([www.AlexGOP.org](http://www.AlexGOP.org)).
