OFFICIAL CALL

Mass Meeting of Albemarle County Committee Of the Republican Party of Virginia

As Chairman of the Albemarle County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Cindi Burket, do hereby issue this call for a Mass Meeting to be held at Lane Auditorium in the Albemarle County Office Building (401 McIntire Road, Charlottesville, Virginia) starting at 6:00 PM local time (doors will open at 5:30 PM) on Monday, March 7, 2016 for the following purposes:

- A) Electing a Unit Chairman;
- B) Electing members of the Unit Committee:
- C) Electing up to 715 Delegates and an equal number of Alternates to the Republican Party of Virginia's 2016 Quadrennial Convention to be held at the James Madison University Convocation Center, located at 895 University Boulevard, Harrisonburg, Va. 22807, convening on April 29, 2016 at 2:30 PM and on April 30, 2016 at 12:00 PM for the following purposes:
- 1. Electing 13 At-Large Delegates ("National Delegates") and 13 At-Large Alternate Delegates ("National Alternates") to the Republican National Convention to be held on July 18-21, 2016, at the Quicken Loans Arena in Cleveland, Ohio

(or its alternate site) (the National Convention);

- 2. Nominating two Electors At-Large to be voted for in the presidential election on November 8, 2016;
 - 3. Electing a State Chairman
 - 4. Electing a National Committeeman and National Committeewoman;
- 5. And for the transaction of such other business as may properly come before the Convention.

A voluntary filing fee of \$35.00 (checks made payable to the Albemarle County Republican Committee) is requested for each Delegate or Alternate. However, failure to pay the requested filing fee will not result in disqualification. Albemarle County is entitled to 143 Delegate Votes that will be equally distributed between actual Delegates that attend the Convention.

- D) Electing up to 715 Delegates and an equal number of Alternates to the 5th U. S. Congressional District Convention to be held at Nelson County High School, Lovingston, VA (or an alternate site if necessary) convening on Saturday, May 14, 2016 at 11:00 AM for the following purposes:
- a) Election of 3 National Delegates for the 2016 Republican National Convention
- b) Election of 3 Alternate National Delegates for the 2016 Republican National Convention
- c) Election of 1 Elector for the 2016 Presidential Election
- d) Election of 3 State Central Committee Members
- e) Election of District Committee Chairman
- f) Election of Candidate for 2016 Congressional Election
- g) Transaction of such other business as may properly come before the Convention

Every person elected as a Delegate or Alternate Delegate to the 5th District Convention will be asked to pay a voluntary \$25.00 fee to help cover the Convention expenses. This fee will be paid to the Unit represented and the Unit will pay the 5th District Committee. Preferential seating will be given to Units based on the percentage of Delegates remitting the fee. Delegates remitting the fee will receive an upgraded convention kit and notation on their credentials. Albemarle County is entitled to 143 Delegate Votes that will be equally distributed between actual Delegates that attend the Convention

E. And for the transaction of such other business as may properly come before the Mass Meeting

Qualifications for Participation

All legal and qualified voters of Albemarle County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

For Mass Meeting registration, all participants shall be required to provide proof of identity in the form of a valid government or employer-issued photo identification. Only those individuals who are registered at the Mass Meeting by 6:00 PM EST on March 7, 2016 or who are in line for registration by that time will be entitled to register and participate in the Mass Meeting.

Pre-Filing Requirements for RPV 2016 Quadrennial Convention Delegate or Alternate Candidates for election as a Convention Delegate or Alternate must submit an official form by U.S Mail or deliver it to the Albemarle County Republican Committee Headquarters, 455 Albemarle Square, Charlottesville, VA 22901 and place form in the designated drop box on the building. The Official form can be downloaded at www.albemarlegop.org. All official forms and the requested filing fees (checks made payable to the Albemarle County Republican Committee) must be received by 5:00 PM, March 3, 2016 and POSTMARKS DO NOT GOVERN. After that time no more pre-files will be accepted.

Pre-filing Requirements for the 5th District Convention:

Candidates for election as a Convention Delegate or Alternate must submit an official form by U.S. Mail or deliver it to the Albemarle County Republican Committee Headquarters, 455 Albemarle Square, Charlottesville, VA 22901 and place form in designated drop box on the building. The official form can be downloaded at www.albemarlegop.org. All official forms and the requested filing fees (checks made payable to the Albemarle County Republican Committee) must be received by 5:00 PM, March 3, 2016 and POSTMARKS DO NOT GOVERN. After that time no more pre-files will be accepted.

Pre-filing Requirements for Chairman:

Candidates for Albemarle County Unit Chairman, shall submit a Pre-file form by U.S. Mail or delivered it to the Albemarle County Republican Committee Headquarters, 455 Albemarle Square, Charlottesville, VA 22901 and place it in the designated drop box on the building. The Pre-file form and a non-refundable filing fee of \$120 (Check made payable to the Albemarle County Republican Committee) must be received by 5:00 PM EST, March 3, 2016.

POSTMARKS DO NOT GOVERN. Nominations for Unit Chair will not be permitted from the floor of the Mass Meeting.

Pre-filing Requirements for Resolutions:

All proposed resolutions must be submitted in writing, by mail or deliver them to the Albemarle County Republican Committee, 455 Albemarle Square, Charlottesville, VA 22901 and place the resolutions in the designated drop box on the building. All proposed resolutions must be received by 5:00 P.M. EST, March 3, 2016, postmarks do not govern. Proposed resolutions will be reviewed by the Resolutions Committee at the Mass Meeting for consideration and adoption. No resolutions will be permitted from the floor.

Registration Fee

For the Albemarle County Republican Committee Mass Meeting there will be no registration fees required to participate.

Composition of Membership

Members of the Albemarle County Republican Committee to be elected at the Mass Meeting shall be according to the precinct where they reside, and a proportional number of At-large seats. Precinct representation is on the basis of one membership for each 15 votes cast for the Republican candidate for the "the office of Governor of the Commonwealth of Virginia" in the last regular preceding election, however, the minimum membership for any precinct shall be three (3) members. Furthermore there are to be an additional number of At-large seats, which shall not exceed thirty percent (30%) of the number of precinct members. The maximum number of members is set forth below:
