

## OFFICIAL CALL FOR MASS MEETING



### *Bath County Republican Committee*

As Chairman of the Bath County Republican Committee of the Republican Party of Virginia and pursuant to the Plan of Organization and as recommended and directed by the committee, I, Jay Trinca do hereby issue this call for a Mass Meeting to be held at the Bath County Court House (Upstairs), 65 Courthouse Hill Road, Warm Springs, Virginia 24484 starting at 7 P.M. local time on February 22, 2016 for the following purposes:

- a. Electing up to 40 delegates for a voting strength of 8 votes and an equal number of Alternates Delegates to the Republican Party Sixth District Convention to be held at the Cave Spring High School, 3712 Chaparral Dr. Roanoke, VA 24018 starting at 10:00 A.M. local time on May 21, 2016 for the purpose to: elect three(3) National Delegates and three (3) National Alternates from the Sixth Congressional District of Virginia to the Republican National Convention; nominating one (1) Elector from the Sixth Congressional District of Virginia to be voted for in the presidential election on November 8, 2016; electing a Chairman for the Sixth Congressional District of the Republican Party of Virginia; electing three (3) Regional Vice Chairman for the Sixth Congressional District of the Republican Party of Virginia; Electing three(3) members to the State Central Committee from the Sixth Congressional District; and for the transaction of such other business that may come before the Convention.
- b. Electing up to 40 delegates for a voting strength of 8 votes and an equal number of Alternates to the Republican Party of Virginia Quadrennial Convention to be held at the James Madison University Convocation Center on April 29-30 2016 to elect 33 at-large delegates and 33 at-large alternatives delegates to the Republican National Convention to be held on July 18-21 2016 at Quicken Loans Arena in Cleveland, Ohio (or its alternate site) (the "National convention"), nominating two Electors At-Large to be voted for in the Presidential election on November 8, 2016, electing a State Chairman, electing a National Committeeman and National Committeewoman; and for the transaction of such other business as may properly come before the Convention.
- c. Electing a Unit Chairman;
- d. Electing members of the Unit Committee;
- e. And for the transaction of such other business as may properly come before the mass meeting.

#### **Qualification for Participation**

All legal and qualified voters of Bath County Virginia under the laws of the Commonwealth of Virginia regardless of race, national origin or sex, who are in accord with the principals of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their

intent to support all the Republican nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective elections districts.

Candidates for delegate, alternate delegate and chairman shall be physically present at the mass meeting.

### **Military Provision**

Otherwise Qualified Military members who seek to be represented at the 6<sup>th</sup> District and or State Convention(s) and who because of the obligation of official military orders, are unable to attend this mass meeting and in lieu of selecting delegates to represent them from the Bath County Republican Committee can instead wish to be represented by a Military Delegation. Military members shall send an email not later than March 17 2016 to Jay Trinca Chairman Bath County Republican Committee [jctrinca@tds.net](mailto:jctrinca@tds.net) and attach a signed Statement of Qualification for a delegate for the Sixth District Convention and or State Convention, and affirmation of their official military orders precluding their attendance and their email address for correspondence.

### **Filing Requirement**

Candidates for Delegate and Alternate for The State and 6<sup>th</sup> district Conventions and Unit Chairman shall file a written statement on a form available at: [www.sixthdistrictgop.com](http://www.sixthdistrictgop.com) or [www.virginia.gop](http://www.virginia.gop) or in person at 134 Lakeview Drive Bacova, VA which must be mailed to the Bath County Republican Committee, PO Box 102 Warm Springs, VA 24484 and received not later 5:00 P.M February 18, 2016. Candidates for membership may file on the same form as delegates or if filing for membership only in person at the mass meeting or by mail to the above address to be received not later than February 20, 2016. A \$20.00 voluntary filing fee made out to the Bath County Republican Committee is requested to defray cost of the mass meeting. Delegates and alternates attending the Sixth District Convention, a \$20.00 voluntary fee is requested and if attending the State Convention a \$35.00 voluntary filing fee is requested. Failure to pay the requested filing fees will not result in disqualification.
