

OFFICIAL CALL
Mass Meeting of the Lee County Committee
Of the Republican Party of Virginia

As Chairman of the Lee County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jason Grace, do hereby issue this call for a Mass Meeting to be held at the Lee County Courthouse, Circuit Courtroom, 5 Main Street, Jonesville, VA 24263 commencing at 6:30 PM local time on Thursday, March 17th, 2016 for the following purposes:

1. The election of party officials, namely a Chairperson, Vice-Chairperson, Secretary, and Treasurer to a new administrative term of two (2) years pursuant to State Party Plan mandates.
2. The Election of delegates to the State Republican Convention to be held in Harrisonburg, Virginia at James Madison University on April 29th and 30th, 2016.
3. The election of delegates to the 9th Congressional District Republican Convention to be held in Wytheville, Virginia on Saturday April 9, 2016.
4. Other such business which is required for consideration of the Republican Party of Lee County at this mass meeting.

Qualifications for Participation

1. Each participating voter in this mass meeting shall be a duly qualified and registered voter with permanent residence in Lee County, Virginia.

Registration and Fees

The doors will open at at 6:00 p.m. The meeting shall begin promptly at 6:30 p.m. No registration fee shall be assessed for attendees. There is no pre-file requirement for voters to this mass meeting. Nominees for election to party office shall promptly return the attached pre-file form to Ms. Sarah Wynn, the current Vice-Chairperson of the Republican Party of Lee County, by 5:00 p.m. EST on March 14, 2016 by the following methods: first-class mail, hand delivery, or e-mail. No floor nominations will be entertained for party office at this mass meeting unless the current administration has not received a pre-file form for that vacant office by the pre-file deadline. If only one (1) pre-file form is timely submitted, then nominations for that party office will automatically close and no additional nominations may be made from the floor of the mass meeting. There is no filing fee for candidates seeking party office.
