

OFFICIAL CALL
Mass Meeting
of the Grayson County Republican Committee
Republican Party of Virginia

As Chairman of the Grayson County Republican Committee (“GCRC”), and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Roger D. Brooks, do hereby issue this Call for a Mass Meeting to be held at the (new) Grayson County Courthouse, Main Courtroom, 129 Davis Street, Independence, VA 24348, starting at 7:00 p.m. on Monday, February 29, 2016, for the following purposes:

1. Electing a Chairman, Vice-Chairman, Treasurer, and Secretary for the GCRC;
2. Electing up to 160 Delegates and an equal number of Alternates to the Republican Party of Virginia (“RPV”) 9th Congressional District Convention (Grayson County is entitled to 32 weighted delegate votes at the District Convention), to be held on Saturday, April 9, 2016, at George Wythe High School, 1 Maroon Way, Wytheville, VA 24382, or its alternative site, beginning at 10:00 AM EDT for the following purposes:
 - a. Electing a 9th Congressional District Republican Committee Chairman (2016-2018);
 - b. Electing 3 Delegates and 3 Alternates to the 2016 Republican National Convention in Cleveland, Ohio, to be held July 18-21, 2016;
 - c. Nominating a Presidential Elector for the 9th Congressional District of Virginia to serve in the 2016 Electoral College;
 - d. Electing 3 RPV State Committee Members representing the 9th Congressional District Republican Committee; and
 - e. For the transaction of such other business as may properly come before the convention;
3. Electing up to 160 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention (Grayson County is entitled to 32 weighted delegate votes at the State Convention), to be held on April 29-30, 2016, at the James Madison Convocation Center, 895 University Blvd, Harrisonburg, VA 22807, or its alternative site, beginning at 2:30 PM EDT on April 29, 2016, and ending on April 30, 2016, for the following purposes:
 - a. Electing a Republican Party of Virginia Chairman (2016-2020);
 - b. Electing 13 Delegates and 13 Alternates At-Large to the Republican National Convention in Cleveland, Ohio, to be held July 18-21, 2016;
 - c. Nominating 2 Presidential Electors At-Large for the 2016 Presidential Election;
 - d. Electing a Committeeman and Committeewoman to the Republican National Committee; and
 - e. For the transaction of such other business as may properly come before the convention;
4. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Grayson County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their

respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter. Voters will be required to produce a valid photo identification card in order to participate in the aforementioned Mass Meeting.

MILITARY MEMBERS ONLY: Otherwise qualified military members who declare via electronic mail to the Chairman of the Convention or his designee, as specified in the Call for the Convention, that because of the obligations of their official military orders, they are unable to attend their respective Grayson County Republican Committee mass meeting, canvass or convention called for the purpose of selecting delegates to a Convention, and that in lieu of selecting delegates to represent them from their respective Grayson County Republican Committee they instead wish to be represented by the Military Delegation, shall be entitled to representation via the Military Delegation.

Filing Requirements/Balloting

Candidates for the election or nomination at said Mass Meeting for:

1. Chairman, Vice Chairman, Treasurer, and Secretary of the GCRC;
2. Delegate and Alternate to the 9th Congressional District Convention on April 9, 2016;
3. Delegate and Alternate to the Republican Party of Virginia Convention on April 29-30, 2016;

must meet the qualifications in this Call and in the Unit, District, Legislative and State Party Plans.

Election shall be by plurality vote of those in attendance.

Registration and Fees

The doors will open at 6:00PM EST, with registration to begin at 6:00PM and end when the Mass Meeting begins. There will be no mandatory registration fee to attend and/or participate in this Mass Meeting. (There is a voluntary \$10 registration fee to participate in the 9th Congressional District Convention, and a voluntary \$35 registration fee to participate in the Republican Party of Virginia Convention.)
