

OFFICIAL CALL

Mecklenburg County Republican Committee (MCRC)
Mass Meeting
Of the Republican Party of Virginia

As Chairman of the Mecklenburg County Republican Committee (MCRC), and pursuant to the Plan of Organization and as recommended and directed by the County Committee, **I, R. Wallace Hudson, do hereby issue this call for a Mass Meeting to be held at the Southside Regional Library at 1294 Jefferson Street, Boydton, VA 23917 starting at 6:30 PM local time on Wednesday, March 23, 2016 for the purposes of:**

- 1) **Electing a Committee Chairman, a Committee Vice-Chairman, a Committee Secretary, a Committee Treasurer**
- 2) **Electing 245 delegates and an equal number of alternates to the 5th District Convention. MCRC has 49 weighted votes.** The 5th District Convention will be held on May 14, 2016 at the Nelson County High School, Lovington, VA 22949 or its alternate site beginning at 11:00 am
- 3) **Electing 245 delegates and an equal an equal number of alternates to the VA State Republican Conventions. MCRC has 49 weighted votes.** The VA State Republican Convention will be held on Friday and Saturday, April 29-30, 2016 at the **James Madison University Convocation Center 895 University Boulevard Harrisonburg, VA 22807** or its alternate site beginning at 2:30 pm local time on the 29th and ending at 5:00 pm local time on the 30th.
- 4) **Accepting MCRC membership applications.**
- 5) **Any other business that should properly come before the Mass Meeting.**

Qualifications for Participation

All legal and qualified voters of the County of Mecklenburg under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Delegates to either Conventions must file an official form for each Convention which is attached to this Call and available at rpv.org. These forms must be filed by mail or in person to the Chairman's address below.
Unit Officer Candidates for the election or nomination at said mass meeting shall file a written statement by mail or in person to:

All forms must be received not later than 5:00pm on March 16, 2016. Postmarks do not govern.

Should only one candidate each file for all unit offices and no more than 245 delegates file for each Convention, then the Mass Meeting may be cancelled.
