

# **Official Mass Meeting Call of the Page County Republican Committee of the Republican Party of Virginia**

I, J. Parker Gochenour, acting Chairman of the Page County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, do hereby issue this notice and call for a Mass Meeting of the Page County Republican Committee to be held on Tuesday, March 15, 2016 at the Luray VFW located at 218 Veterans Ln, Luray, VA 22835, starting at 6:30 P.M with registration beginning at 6:00 PM for the following purposes:

1. Electing up to 200 Delegates and an equal number of Alternates (with a voting strength of 40 votes) to represent the Committee at the State Convention of the Republican Party of Virginia which shall be held on April 29-30, 2016, at the James Madison University Convocation Center, 895 University Boulevard, Harrisonburg, VA 22807.
2. Electing up to 200 Delegates and an equal number of Alternates (with a voting strength of 40 votes) to represent the Committee at the Republican 6th District Convention which shall be held on May 21, 2016, at the Cave Spring High School, 3712 Chaparral Drive, Roanoke, Virginia 24018, starting at 10:00 am.
3. Electing a Chairman of the Page County Republican Committee.
4. Electing members of the Page County Republican Committee.
5. Transact such other business as may properly come before the Mass Meeting.

## **Qualifications for Participation**

All legal and qualified voters of Page County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## **Filing Requirements**

**Candidates for election as Delegates and Alternates to the State Party Convention** shall file a form, which is a written statement of intention, by email or in person, to the Secretary of the Page County Republican Committee, Diane Buckley at [pagegop@gmail.com](mailto:pagegop@gmail.com). The form must be received no later than 5:00 pm, Friday, March 11, 2016. The form for filing to be a candidate for Delegate or Alternate is attached to this Call.

**Candidates for election as Delegates and Alternates to the 6th Congressional District Convention** shall file a form, which is a written statement of intention, by email or in person, to the Secretary of the Page County Republican Committee, Diane Buckley at [pagegop@gmail.com](mailto:pagegop@gmail.com). The form must be received

no later than 5:00 pm, Friday, March 11, 2016. The form for filing to be a candidate for Delegate or Alternate is attached to this Call.

**Candidates for election to the office of Chairman of the Page County Republican Committee** shall file a form, which is a written statement of intention, by email or in person, to the Secretary of the Page County Republican Committee, Diane Buckley at pagegop@gmail.com. The form must be received no later than 5:00 pm, Friday, February 12, 2016. The form for filing to be a candidate for Delegate or Alternate is attached to this Call.

**Candidates for election as Members of the Page County Republican Committee** may file a form, which is a written statement of intention, by email or in person, to the Secretary of the Page County Republican Committee, Diane Buckley at pagegop@gmail.com. The form must be received no later than 5:00 pm, Friday, March 11, 2016 or presented at the Mass Meeting. Members may be elected from the floor of the Mass Meeting. The form for filing to be a member of the Page County Republican Committee is attached to this Call.

No nominations for offices to be filled by the Mass Meeting may be made from the Floor except for election as Members of the Page County Republican Committee or upon the vote of two-thirds of those properly credentialed to vote at the Mass Meeting.

### **Voluntary Filing Fees for the District and State Conventions**

To assist the operations of the Republican Party of Virginia in supporting Unit mass meetings and conventions, and the administration of the District and State Conventions, a voluntary candidate filing fee of \$35.00 is requested of each person standing for election as a delegate or alternate delegate to the State Convention. A voluntary candidate filing fee of \$20.00 is requested of each person standing for election as a delegate or alternate to the District Convention. Failure to pay the requested voluntary filing fee will not result in disqualification. The acting Chairman of the Page County Republican Committee recommends that all Delegates and Alternates to the District and State Conventions pay the voluntary fees.

### **Election of Convention Delegates and Alternates, Chairman and Committee Members**

Persons seeking election as Convention Delegates, Convention Alternates, Committee Chairman and Committee Members **may** be physically present at the Mass Meeting to be elected. Persons who seek Committee membership, but are unable to attend the Mass Meeting, may request membership at a subsequent meeting of the Committee.

### **Registration Fee**

There will be no registration fee to participate in the Mass Meeting.

### **Proper Notice**

A full copy of this Call for a Mass Meeting shall be posted, and available on the Sixth Congressional District Committee of the Republican Party of Virginia website ([www.sixthdistrictgop.org](http://www.sixthdistrictgop.org)) and the Republican Party of Virginia website ([www.virginia.gop](http://www.virginia.gop)). In accordance with Article 8, Section A2 of the Republican Plan of Organization the required publication in a newspaper is waived.
