

OFFICIAL CALL - MASS MEETING
Rappahannock County Republican Committee
Monday, February 29, 2016 at 6:30 PM

As Chairman of the Rappahannock County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Angela D. Deavers, do hereby issue this Call for Mass Meeting to be held beginning at 6:30 PM local time on Monday, February 29, 2016, at the Rappahannock County Court House, 250 Gay Street, Washington, VA 22747, for the purpose of:

1. Electing a Unit Chairman;
2. Electing Members of the Rappahannock County Republican Committee Unit;
3. Electing up to 75 Delegates and an equal number of Alternates to the Republican Party of Virginia's 2016 Quadrennial Convention, commencing at 2:30 pm EDT on April 29, 2016 and ending on April 30, 2016 at the Convocation Center of James Madison University located at 895 University Boulevard, Harrisonburg, Virginia 22807 or its alternate site, for the following purposes:
 - A. Electing 13 At-Large Delegates (National Delegates) and 13 At-Large Alternate Delegates (National Alternates) to the Republican National Convention to be held on July 18-21, 2016 at the Quicken Loans Arena in Cleveland, Ohio (or its alternate site) (the "National Convention");
 - B. Nominating two Electors At-Large to be voted for in the presidential election on November 8, 2016;
 - C. Electing a State Chairman;
 - D. Electing a National Committeeman and National Committeewoman;
 - E. And for the transaction of such other business as may properly come before the Convention.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Rappahannock County is entitled to 15 Delegate Votes.

4. Electing up to 75 Delegates and an equal number of Alternates to the Fifth Congressional District Convention, commencing at 11:00 am EDT on May 14, 2016, at Nelson County High School located at Lovingston, Virginia, or its alternate site, for the following purposes:
 - A. Election of 3 National Delegates for the 2016 Republican National Convention
 - B. Election of 3 Alternate National Delegates for the 2016 Republican National Convention
 - C. Election of 1 Elector for the 2016 Presidential Election
 - D. Election of 3 State Central Committee Members
 - E. Election of District Committee Chairman
 - F. Election of Candidate for 2016 Congressional Election
 - G. Transaction of such other business as may properly come before the Convention

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Rappahannock County is entitled to 15 Delegate Votes.

5. And for the transaction of such other business as may properly come before the Mass Meeting.

Qualifications for Participation

All legal and qualified voters of Rappahannock County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates standing for election as delegates or alternates to the state or congressional district conventions at said Mass Meeting shall file a written statement by mail or in person to Angela D. Deavers, 448 Laurel Mills Road, Castleton, Virginia 22716-2702 or by e-mail to adeavers@yahoo.com, which must be received no later than 6:00 PM on Sunday, February 28, 2016; postmarks will not govern. Pre-filing for the office of Chairman of the unit committee is also due at that time. The filing forms can be obtained from Angela D. Registration Fees

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from each individual seeking election as a State Convention Delegate (convention seating is determined by % of fees received from each unit).

The Fifth Congressional District Committee is requesting a voluntary \$25 filing fee from each individual seeking election as a District Convention Delegate (convention seating is determined by % of fees received from each unit).
