

OFFICIAL CALL

Mass meeting of the Tazewell County Committee of the Republican Party of Virginia

As Chairman of the Tazewell County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Wanda Lowe, do hereby issue this call for a Mass Meeting to be held at Nucholls Hall at 515 Fairground Road in Tazewell, Va., starting at 7:00 PM local time on February 15, 2016 for the following purpose:

- A. To elect a Tazewell County Republican Committee Chairman, Vice Chairman, Secretary, and Treasurer and county committee members.
- B. To elect 425 delegates and alternates to the 9th District Republican Committee's Convention to be held April 9, 2016 at the George Wythe High School at 1 Maroon Way in Wytheville, Va. Tazewell County is entitled to cast 85 weighted delegate votes at the District Convention.
- C. To elect up to 425 delegates and alternates to the Republican Party of Va State Convention to be held April 29-30, 2016 at Harrisonburg, Va. Tazewell County is entitled to cast 85 weighted delegate votes at the State Convention.
- D. And for the transaction of such other business as may properly come before the meeting.

QUALIFICATIONS FOR PARTICIPATING

All legal and qualified voters of Tazewell County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party of Virginia, and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

FILING REQUIREMENTS

Each person who wishes to be considered as a Republican candidate for the election of, or nomination to an office of the Tazewell Republican Committee or participate as a delegate to the Tazewell Mass meeting and or a delegate to the 9th District Convention and or the State Convention shall file a written Candidate Filing or delegate form.
