

OFFICIAL CALL
Mass Meeting of Dickenson County Committee
of the
Republican Party of Virginia

As Chairman of the Dickenson County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Gary Hall, do hereby issue this call for a Mass Meeting to be held at A. M. Phipps Headquarters, Dickenson Hwy, Clintwood, Virginia 24228 starting at 7:00 p.m.. local time on March 14, 2016 for the following purposes:

A.) Nominating and electing a Dickenson County Unit Committee Chairman; 1st Vice Chairman; 2nd Vice Chairman; Secretary, Treasurer, and members of the unit committee.

B.) Elect up to 130 Delegates and Alternates to represent the Committee at the State Convention of the Republican Party of Virginia which shall be held on April 29-30, 2016, at the James Madison University Convocation Center, 895 University Boulevard, Harrisonburg, VA 22807 or its alternate beginning at 2:30 p.m on April 29th and at 12:00 p.m. on April 30th for the following purposes:

1. Electing a Chairman for the Republican Party of Virginia;
2. Electing 13 At-Large Delegates and equal number of Alternate Delegates to the Republican Party National Convention to be held on July 18th-21st, 2016 at the Quicken Loans Arena in Cleveland, OH or alternative location;
3. Electing presidential electors for the Republican Party of Virginia;
4. Electing a National Committeewoman and National Committeeman to the Republican National Committee; \
5. and for the transaction of such business as may properly come before the convention.

C.) Elect up to 130 Delegates and Alternates to represent the Committee at the Republican 9th Congressional District Convention which shall be held on April 9, 2016, at George Wythe High School, #1 Maroon Way, Wytheville, Virginia 24382, or its alternative location, starting at 10:00 a.m. local time for the following purposes:

1. Electing a Chairman for the Ninth Congressional District of the Republican Party of Virginia for the 2016-2018 term.
2. Electing three National Delegates and three alternate Delegates from the Ninth Congressional District of Virginia to the Republican National Convention to be held on July 18-21, 2016 at the Quicken Loans Arena in Cleveland, OH or its alternative location;
3. Electing a presidential elector for the Ninth Congressional District of Virginia Republican Committee;
4. Electing three members to the State Central Committee from the Ninth Congressional District for the 2016-2020 term;
5. And for the transaction of such business as may properly come before the convention.

D) Transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Dickenson County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters will be required to produce personal identification such as a valid driver's license or voter registration card in order to participate in the mass meeting or convention.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years. A single exception to this rule shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of writing, to support the nominees of the Republican Party in the future.

Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of this exception thereafter.

Filing Requirements

All nominations for the Dickenson County Republican Party offices and for the election of delegates/alternates to the state and/or district conventions will be accepted from the floor, so therefore, no filings will be required.

Registration Fee

There will be NO registration fee to participate in this mass meeting.

There is a voluntary registration fee of \$35.00 to participate in the Republican State Convention and a \$10.00 registration fee to participate in the 9th District Convention.

Registration for the Dickenson County Mass Meeting participants will begin at 6:00 p.m. and close at the start of the mass meeting at 7:00 p.m..

No resolutions shall be considered by the Dickenson County Mass Meeting.
