

HALIFAX COUNTY REPUBLICAN COMMITTEE
MASS MEETING CALL
MARCH 17th, 2016

As chairman of the Halifax County Committee of the Republican Party of Virginia, and pursuant to the plan of organization and as recommended and directed by the Committee I, Pat Barksdale, do hereby issue this call for a Mass Meeting to be held at the World of Sports Complex, 2130 Bill Tuck Highway, South Boston, Virginia 24592. (Or in the event another location is needed the chairman is authorized to make the changes.) Starting at 6:00 pm registration, Thursday, March 17th, 2016. Meeting to start promptly at 7:00 pm. For the Following purposes:

1.) Electing up to 285 Delegates and an equal number of Alternates to the State Quadrennial Convention of the Republican Party, to be held on April 29 – 30, 2016 at the James Madison University Convocation Center, 895 University Boulevard, Harrisonburg, Virginia 22807 or if needed, and alternate site, Convening 4 – 29 at 2:30 pm and 4 – 30 at 12:00 Noon. For the transaction of :

- A. Electing 13- at Large Delegates (National Delegates) and 13 at – Large Alternate (National Delegates) to the Republican National Convention to be held July 18-21, 2016 at the Quicken Loans Arena in Cleveland, Ohio (or its alternate site) (the National Convention.)
- B. Nominating two Electors at – Large to be voted for in the Presidential Election on November 8th, 2016;
- C. Electing a State Chairman;
- D. Electing a National Committeeman and a National Committeewoman;
- E. And for the transaction of such other business as may properly come before Convention;

A voluntary filing fee of \$35.00 made payable to the Halifax County Republican Committee is requested per delegate/ alternate.

2.) Halifax County can elect up to 285 Delegates and an equal number of Alternates to the 5th District Convention to be held on Saturday, May 14, 2016 at 11:00 am Nelson County High School Lovingson, Virginia or an alternate site if necessary. For the transaction of:

- A. Election of 3 National Delegates for the 2016 Republican National Convention
- B. Election of 3 Alternate National Delegates for the 2016 Republican National Convention
- C. Election of 1 Elector for the 2016 Presidential Election

- D. Election of 3 State Central Committee Members
- E. Election of District Committee Chairman
- F. Election of Candidate for 2016 Congressional Election
- G. Transaction of such other business as may properly come before the Convention

The Fifth District Convention is requesting a \$25.00 voluntary fee payable to Halifax County Republican Committee is appreciated to help our District with cost. 3.) The Halifax County Mass Meeting will also be:

- A. Electing Members of the Halifax County Republican Committee;
- B. Electing a Chairman HCRC
- C. Transaction of such other business as may properly come before the Mass Meeting.

Anyone who desires to run for Unit Chairman must pre-file an official form with Pat Barksdale at 7010 Melon Road, Sutherlin, VA 24594 by March 10, 2016 at 5:00 pm, post marks do not govern.

Anyone who desire to be elected a delegate or alternate delegate to the 5th District Convention or the State Convention must submit an official pre-file form by U.S. Mail or deliver to Pat Barksdale 7010 Mellon Rd, Sutherlin, VA 24594 by March 10, 2016 at 5:00 PM. Postmarks do not govern. No pre-file forms will be accepted after this deadline. Forms may be obtained from Pat Barksdale or on rpv.org.

Qualification for participation all legal and qualified voters of Halifax County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party who, If requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the election, may participate as members of the Republican Party of Virginia in the Mass Meeting, party Canvasses, Conventions, Primaries, encompassing their respective election districts. There is no fee to attend the Mass Meeting.

Should 285 or less delegate candidates pre-file for both Conventions and should only one candidate file for Unit Chairman, the Mass Meeting may be cancelled.
