I, James Ennis, Chairman of the Martinsville Republican Committee, a unit of the 9th Congressional District of the Republican Party of Virginia with consent of the unit members do issue this Call for a Mass Meeting to:

- a) elect a chairman for the Martinsville Republican Unit Committee
- b) appoint ≤ 75 delegates for the 9th Congressional District Convention on April 9, 2016
- c) appoint ≤ 75 delegates for the Republican Party of Virginia Convention on April 29 + 30, 2016
- d) transact other business that may come before the Mass Meeting

Qualifications for Participation

Legal qualified voters under the laws of the Commonwealth of Virginia who are in accord with the principles (the written Creed) of the Republican Party of Virginia and who report affirmatively, should they be requested, either orally or in writing, their intent to support all the nominees for public offices in the ensuing election.

Otherwise Qualified Military Members who declare via electronic mail to the Chairman of the Convention or his designee, as specified in the Call for the Convention, that because of the obligations of their official military orders, they are unable to attend their respective Unit mass meeting, canvass or convention called for the purpose of selecting delegates to a Convention, and that in lieu of selecting delegates to represent them from their respective Unit they instead wish to be represented by the Military Delegation, shall be entitled to representation via the Military Delegation

Otherwise Qualified Military Members who wish to be represented by the Military Delegation shall send an e-mail declaration which shall include attached a signed statement of intent to support all Republican Nominees in the General Election, an affirmation of their official military orders precluding their attendance, and their email address for correspondence. The declaration shall be emailed to martinsvillegop@gmail.com not later than March 4, 2016. Subsequent to the receipt of the Declaration, Qualifying Military Members will be sent a Ballot Preference Form to be returned by email, as directed, prior to the Convention.

Pre-filing/Registration Fees and Deadlines

- For Unit Chairman, no registration fee but the pre-file is required before March 5
- For 9th District Convention Delegate, a voluntary \$10 registration fee and a pre-file document to:

- For Republican Party of Virginia Convention Delegate, a voluntary \$35 fee and Pre-file form or in person as stated above for the 9th District Delegates
- Alternate Delegates are permitted to register for registered Delegates and are required to pre-file or apply at the Mass Meeting as stated for Delegate registrations
