

**OFFICIAL CALL**  
**Mass Meeting of the Westmoreland County Republicans**  
**of the Republican Party of Virginia**

As Chairman of the Westmoreland County Republican Committee (WCRC), and pursuant to the Plan of Organization of the Republican Party of Virginia and as recommended and directed by the Committee, I, Jennifer Peters, do hereby issue a Call for a Mass Meeting of the WCRC to be held Friday, March 11, 2016 at the A.T. Johnson Building, 18849 Kings Highway, Montross, VA 22520 starting at 7:00 p.m. with registration starting at 6:00 p.m. and ending at 7:00 p.m., for the following purposes:

- a) Electing a Unit Chairman
- b) Electing members of the Westmoreland County Republican Committee from the following Precincts: 101 and 102 (Kinsale & A.T. Johnson); 201 (Cople); 301 (Montross); 401 (Oak Grove); 501 (Colonial Beach).
- c) Electing Delegates and Alternates to the Republican Party of Virginia State Convention, to be held on April 29<sup>th</sup> through the 30<sup>th</sup> at the James Madison University Convocation Center, 895 University Boulevard, Harrisonburg, VA for the purpose of electing a State Party Chairman, RNC National Committeeman, RNC National Committeewoman, 13 At-Large Delegates and 13 At-Large Alternate Delegates to the RNC Convention, and two At-Large Presidential Electors.
- d) Electing Delegates and Alternate Delegates to the First Congressional District Convention, to be held on May 7, 2016 at James Monroe High School, 2300 Washington Ave, Fredericksburg, VA, beginning at 4:30p.m. for the purposes of electing a District Chairman, three (3) Delegates and three (3) Alternate Delegates to the RNC Convention, a Presidential Elector, and three (3) members of the Republican State Central Committee.
- e) For the transaction of such other business as may properly come before the Mass Meeting.

**QUALIFICATIONS FOR PARTICIPANTS**

All legal and qualified voters of Westmoreland County under the laws of the Commonwealth of Virginia, regardless of race, religion, sex or national origin, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing general election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

**FILING REQUIREMENTS**

Candidates for election to offices, per subparagraph a) above, of the Westmoreland County Republican Committee at said Mass Meeting shall file a written statement to Chairman Jennifer Peters 895 Long Point Road, Hague, VA which must be received no later than 5:00p.m. on Friday, March 4, 2016. Forms for this pre-filing can be obtained from the WCRC Chairman at 540-288-7483.

Candidates for election as Delegates and Alternates to the April 29<sup>th</sup> Republican State Convention and to the May 7<sup>th</sup> First Congressional District Convention, shall file a form, to be provided by the Committee, stating their intent to seek election. This form shall be submitted to Chairman Jennifer Peters 895 Long Point Road, Hague, VA 22469 which must be received no later than 5:00 p.m. on Friday, March 4, 2016. Registration fees for filing as Delegates and Alternate Delegates are identified below.

**REGISTRATION FEE**

There will be no registration fee to participate in this Mass Meeting. There is a voluntary registration fee of \$35.00 to participate in the Republican State Convention, and a voluntary fee of \$5.00 to participate in the First Congressional District Convention.
